Simon says...

It was great to have all that rain and no serious flood. Pisceans like me get quite frisky with all that water around. I still have the occasional chuckle when I remember that every one of the candidates in the last council elections submitted their star sign for their 'Meet the Candidate' article in that other paper. Where else in the western world would that happen (excluding Byron)? Trish commented that there are a lot of Virgos (well she would notice a detail like that).

Reflecting on the last month it has been a great month for Indigenous issues. Firstly on 14th April Councillors unanimously supported my motion to have the Aboriginal flag displayed in the front of the council chamber, along with the Australian flag and the City of Lismore flag. It is a symbolic gesture and important for the Bundjalung Elders Council which meets regularly in the chamber.

Secondly, I attended a workshop on the restoration of Slaters Creek which wends its way through the paddocks of North Lismore. It was an empowering gathering with 4-5 Indigenous representatives and 20 others all committed to making this

part of North Lismore come alive with walking trails and appropriate revegetation.

I filled in for the Mayor at the launch of the Ngulingah Local Aboriginal Land Council's project "Restoring biodiversity and traditional knowledge around Nimbin Rocks". It was an inspiring morning, with lots of optimism about the project. It will employ about 8 Indigenous workers for clearing and revegetating the land and will continue for 5 years.

It may be my imagination but I'm getting the distinct impression that there is a strong upswing of interest in council. For instance I attended a lively city forum on 20th April where 30 residents were present. Topics included Nesbitt Park, drainage in South Lismore, the speedway, homeless shelter and housing availability.

I'm very excited about the Northern Rivers Food Connect project. This project is a collaboration of 7 councils in the region and has a budget of \$2M. The project has objectives including health promotion, a cleaner environment and of course the availability of fresh locally grown food. I'm hoping that it will deal with the absurdity of the legendary organic avocado that is grown here, is shipped to Melbourne via Brisbane with multiple re-wrappings and treatments before it finally returns to Lismore to be sold and eaten "locally"!

I think the 'Food Connect' project is just what we need when the community is facing the reality of climate change and the challenge of peak oil.

Nimbin carpark lighting

In response to a question in April from Cr Clough, Lismore City Council's Corporate Compliance Co-ordinator, Graeme Wilson replied:

"Council has awarded a contract for installation of nine solar lights in the western carpark. Because of the cost of the work, the project has had to be split into two stages, with

this work representing stage 1.

"Staff will liaise with the Chamber of Commerce and the Police to determine which section of the carpark should be lit first. The work is expected to be complete by the end of May. In regard to stage 2, a budget submission has been made and staff are also pursuing grants for this part of the work."

Vale John Hampton

On April 30, 18 Councillors both past and present from LCC formed a guard of honour to pay tribute to John Hampton who died of cancer on April 24. After nearly 32 years on the planning staff of several North Coast Councils including Lismore, John served two full terms as a Councillor until the elections in September 2008. His contribution to local government in our area for over 40 years is worthy of celebration and gratitude. Our deepest sympathies go to his wife Margaret, daughters Liz and Katharine and their families.

General Manager's Performance Monitoring

One of the most important roles of a Council is to choose its General Manager and to review and monitor his/her performance. The new committee comprising four Councillors with guidance from the professional services of Mark Anderson of the LGSA, has carried out the Monitoring session of our GM, Paul O'Sullivan. In confidential session, as required by the rules of the DLG, Council has endorsed the 2008/09 Performance Plan and expressed its satisfaction with the performance of our GM during the monitoring period.

Aboriginal Flag

Council has flown the Aboriginal flag in front of its corporate centre for many years but in the

Chambers itself only the Australian flag and Lismore's own flag (designed by ex-CAE lecturer and artist Lionel Gailer) are displayed behind the Mayor's chair. At our April meeting we determined to include the Aboriginal flag there too (proposed by Cr Clough). The decision has met with approval from Bundjalung Elders whose own Council meet regularly in the room.

Investments

Council continues to suffer from our connection to Lehman Brothers Holdings through various investments and we are now advised that while a capital loss of \$791,000 has already been recognised, a further significant loss is expected. The Trustees for LBH are commencing legal action to terminate several investments so Council has instructed the Trustees that we endorse that termination. The loss of investments is linked with what has become known as the Global Financial Crisis (GFC). Councillors are well aware of the implications for the coming budget so I take this opportunity of forewarning readers that there will be little joy in the coming months before the final determination of LCC's budget and management plan for the new financial year.

Community Garden

At the meeting, Council also gave in-principle approval of a Community Garden for Lismore (moved by Cr Houston). As readers would realise, community gardens are increasingly popular as a way of connecting people with the food they consume, of promoting healthy activity and of bringing different people together. Investigations are still progressing for a suitable site after several alternatives fell through. Stay tuned for further developments.

Circuses

Council also decided to ban animal circuses from

Lismore LGA on Council owned land. We join 36 other Councils throughout Australia to introduce such a ban on the premise that the community no longer accepts the use of animals performing unnatural acts for human entertainment or the desirability of keeping and transporting animals in small enclosure. Since Cr Battista proposed and Council endorsed the motion, I have been inundated with emails of congratulations from throughout Australia and overseas.

Nimbin roads

Regular travellers on Nimbin Road at Goolmangar will note that work has commenced to reduce the nasty bend .5km north of the Jiggi corner. This work was identified under the Federal Blackspot Funding Program and involves negotiations with the landowners on both sides of the road so that, through purchase or swap, Council can dispose of and acquire the necessary land to improve the road alignment. Council also agreed to an application from the owners of land off Stony Chute Rd that a section of an unformed and un-named road 4.3 kms west of Nimbin, be closed. This type of application is not uncommon as there are many 'paper roads' throughout our LGA. The process involves some administrative and legal costs that are met by the landowner and payments for the land to the Department of Lands. The DoP will advertise the closure for public submissions.

Planning Review

In response to several recent planning and building approvals that have met with complaints, Council senior staff has instituted an external 'desk-top' review of Council's processes. Pamela Westing is conducting the review and examining several specific cases to develop some recommendations that will improve the way Council undertakes its assessment

process.

Mayor's Discretionary Fund

Congratulations to Sophie Boyle of Goolmangar who has been selected to participate in the 2009 NSW YMCA's Youth Parliament. Sophie wrote to me to request financial assistance and I was happy to make a small donation through my discretionary fund. This fund is available for other small donations for worthwhile projects and can be requested through a letter to me at Council.

Alcopops

The Rudd Government is not giving up on its policies to address teenage binge drinking.

The Treasurer Wayne Swan and Health Minister Nicola Roxon have announced that they will reintroduce the alcopops measure as part of the Government's ongoing commitment to the fight against binge drinking.

This measure ensures that all spirits are taxed at the same rate, whether they are consumed as alcopops or full strength spirits. The Rudd Government does not think that sugary, colourful drinks targeted squarely at underage drinkers deserve the tax break created by the Liberal National Party coalition in 2000.

The Government's alcopops measure is supported by health experts, police superintendents and community groups. When the alcopops tax was in place there was a 35 per cent fall in the consumption of alcopops and a significant fall in spirits consumption overall and the Australian Medical Association has said it would be a retrograde step if the alcopops tax did not go through.

We are not prepared to abandon these gains in a vital area of public health, despite the coalition's efforts to obstruct this measure and protect the alcopops industry. The Liberal National party coalition needs to explain why it is fighting so hard to give this tax break to the big distillers.

The Rudd Government's alcopops legislation is part of a broader strategy to tackle teenage binge-drinking with advertisements, grassroots initiatives and an unprecedented investment in preventative health.

Climate Ready Grant for the Page

I was delighted to announce that a local project, Ethanol Technologies Limited (Ethtec), received the biggest grant in the latest round of Climate Ready grants. The grant of \$2.9 million is for the next stage of its project to produce ethanol from sugar industry waste. By using

agricultural waste products, this project removes the food versus fuel debate from ethanol production.

Ethtec has the exclusive licence in Australia to use this technology developed by Dr Russell Reeves, which involves separating acid and sugars for ethanol from lignocellulosic material.

I recently visited the Ethtec site at Harwood Sugar Mill and Dr Russell Reeves explained the process he has invented. It is wonderful to see a local project leading the way with climate ready technology. The Innovation Minister, Senator Kim Carr announced a total of \$16.4 million in Climate Ready grants for 19 Australian businesses in the latest round.

Annual national free flu vaccination for over 65's

I was recently joined by the Member for Page Janelle Saffin and Australia's Ambassador for Ageing, Noeline Brown to officially launch the Rudd Government's annual free flu vaccination program for people over 65.

The Federal Government will spend more than \$28.8 million on influenza and related programs in 2008-09 with record supplies of vaccinations being distributed to prepare for this year's flu season.

Currently, there are some 2.8 million Australians – about 13 per cent of the population – aged 65 and over. This number is expected to triple in 40 years.

If you are over 65, you are eligible for the free influenza shots to protect yourself from potentially life-threatening winter illness.

It is recommended to have the vaccination close to the flu season – usually April to October. (It generally peaks in August).

\$720,000 for two Black Spots to be fixed

Road accidents are a major cost to all Australians every year and the Rudd Government is making road safety a priority with a significant increase to Black Spot funding.

Nationally, the funding for the Black Spot Program for 2008/09 has been almost tripled from \$50 million to \$144.7 million under the Government's Nation Building plan to support jobs.

The Black Spot Program has a proven track record of saving lives, with an evaluation of the program showing that it prevented at least 32 fatalities and more than 1,500 serious injuries in its first three years.

With that in mind I am pleased to announce, along with the Minister for Infrastructure and Transport, Anthony Albanese, the investment

of \$720,000 to fix two additional dangerous black spots on local roads.

The two additional projects on the north coast that have been approved as part of the Government's \$42 billion Nation Building and Jobs package are:

- \$550,000 will be provided to install a left turn lane and a protected right turn lane at the intersection of Lismore to Bangalow Road and Eureka Road at Clunes; and

- \$170,000 is being made available to install advisory and curve signage and reflectors on guideposts on Murwillumbah Road from Lillian Rock Road to Uki.

This extra investment will support local jobs, deliver safer roads and will also return around \$14 for every \$1 invested, by reducing the number and cost of crashes.

The projects were assessed and recommended by a panel of independent road safety experts including the NRMA, Federation of P&C Associations of NSW, Council on the Ageing, and Institute of Public Works Engineering Australia.

The Rudd Labor Government has more than doubled Black Spot funding as part of our Nation Building and Economic Stimulus Strategy.


have the right to refuse them service," as much as to say, "We can't do anything."
