Stewart and Elaine Godwin (*pictured*) say their experience with coal seam gas mining has made them very angry.

"The drilling is the worst thing, and the generator. The drilling grinds and makes a whooshing noise like a jet coming up the road, it's steel on rock.

"The noise is an unbearable throbbing. It gets right inside your head, a pressure that feels like it's a brain tumour and makes your eyes water. It stays inside your head even when you go out for the day to get away from it, and stays there for months.

"Sleep is impossible because they drilled several times for 3-4 weeks at a time, all day and all night, it's torture.

This is happening 18kms from Kyogle at Dobies Bight, hidden out of view from the main road, where people can't see or hear what's going on. "One well is 210m from

our front door, the second is 1.5km away, and it feels like the drill goes horizontally straight under our feet, the whole house shakes, even the fans.

"It took 30 B-double trucks to gravel the site, as well as all the clanging and banging of pipes. One neighbour tried to build a wall to stop the noise, but of course that didn't work.

"The gas plumes are as high as the roof of our house and the sky is sometimes red with



the glow. Also it's a big wind area here and when it comes up we're very scared that it's going to get away.

"Metgasco put banks of floodlights on their fence facing our house, they're on constantly and so bright that you could mow the lawn at night.

'You're all alone, no one helps you, we tried the government, police, EPA, Metgasco, Thomas George, Council, Barry O'Farrell, but no one listens.

"Peter Henderson from Metgasco has never bothered to come to hear the noise and see what it's like.

"The people who have wells and dams on their land are benefiting from all this, but there's nothing for us. People should be sued for damage caused to adjacent properties.

"We moved to the country for the peace and quiet, and now we've got nothing, nothing. We're stuck with this for life, we'll never be able to sell.

Metgasco and Arrow. The patrol vans are equipped with the latest electronic equipment to monitor and record information and to inform the public on the movements of CSG companies.

Daily updates will be made available on Twitter and Facebook to give communities warning of pending threats in their localities and to give threatened communities the heads-up to mobilise.

Glenugie residents were taken by surprise last week when Metgasco began preparations for a drill site without informing neighbouring landowners. Work has halted due to a



Metgasco's Awful **General Meeting**

Residents of the Northern Rivers went to Sydney for the Metgasco 2012 AGM on 13th November and held banners and large laminated signs supplied by Annie Kia, proclaiming Coal Seam Gas as risky business.

The Sydney media were alerted by Jacinta Green of CSG-free Sydney, and she did an interview on 2GB radio. Demonstrators conservatively dressed as North Sydney business people handed flyers to Metgasco shareholders as they arrived for the meeting.

When CEO Peter Henderson arrived, surrounded by a cohort of colleagues, he refused to take the proffered flyer.

During the meeting he derided the significant opposition by local communities as "melons": green on the outside, red inside. He claimed that downgrading the power plant at Casino from 30mw to 6mw (or even 3mw) would not affect their production licence. Neither the application to

the NSW government nor the conditions imposed for that licence have been made public. Anti-CSG activists are looking into prospects for mounting a court challenge to their production licence.

If successful this action could be the end for Metgasco. Financially, Metgasco is on the ropes, with losses of \$5 million in the past year and share prices down to around 19c. Shareholders are extremely unhappy with the creation of new shares sold at reduced prices to try to raise capital.

If Metgasco doesn't start selling gas in the next 12 months it will be in real trouble.

Some investors told NRG they voted against the

nearly a million free shares as "an incentive bonus" because the share price has fallen from more than 50 cents a year ago to less than 20 cents now.

The share price in 2008 was more than \$1.20. The chairman said it wasn't Henderson's fault as the NSW Government had held up Metgasco with its CSG moratorium.

The meeting reluctantly agreed to give Henderson another 12 months to get it right. Henderson apparently thinks the intended drilling program will convince the local community (which voted 87% against CSG mining in local government elections) that Metgasco can be trusted and that CSG is "safe."

Metgasco's strategy over the next 12 months is to win popular support by convincing people NSW is facing a gas shortage and that CSG is vital to economic survival.

Henderson said he still favoured a pipeline over Lion's Way, but he admitted that local landholder opposition would cause expensive delays to an attempt to build a gas pipeline over the Border Ranges into Queensland, which would cost at least \$150m.


He suggested that a pipeline to a loading dock offshore from Ballina could be an attractive alternative, and said none of the easements would require payments to landholders from Metgasco.

The protestors told anyone who would listen that Northern Rivers people had a long history of protecting the environment and would fight CSG all the way, making Metgasco a very risky investment.

The mood among investors was sour with many saying they would hold on for a while, hoping for an increase in share value rather than lose

Nimbin Water Supply

A report on options for the upgrade of the Nimbin Water Supply is scheduled to go before Lismore City Council on Tuesday, 11 December. Feedback received from residents during community consultation will be presented to Councillors as part of the report.

Council would like to thank all Nimbin residents who participated or provided feedback during the community consultation process. The meeting begins at 6pm and members of the public are welcome.

Upcoming Nimbin road works

Road works on Nimbin Road adjacent to High Street (beginning near the 50 speed sign as you enter the village) are likely to commence in February next year. This will include a 400m road reconstruction and widening with an upgrade of the existing drainage structure.

There will be traffic control in place and short time delays coming in and out of the village. Work is expected to take eight weeks, weather permitting. This project is jointly funded by the Regional Road Repair Program and Lismore City Council.

Expressions of Interest for Draft Biodiversity **Management Strategy**

Lismore City Council is about to commence the development of a Draft Biodiversity Management Strategy (Draft BMS). Council wants to involve the community in the development of the Draft BMS from the inception of the project.

To this end, a Stakeholder Reference Group (SRG) will be established with membership from a diverse range of industry and community interest groups. Members of the Stakeholder Reference Group will provide knowledge, information and help shape the Draft BMS.

Expressions of Interest are currently being sought from individuals as well as special interest groups. Preference will be given to those applicants who are members of and endorsed by a recognised industry or community interest group operating within the Lismore Local Government Area.

It's about education

I write with grave concerns regarding the future of community-based preschools in NSW, like Nimbin Preschool. Since 1989, community preschools have either been in a funding freeze or a state of sporadic and unreliable funding where services and families have no surety of future funds or how they will be allocated.

In 2013 fees at NSW community based preschools will be the highest they have ever been - up to \$55 a day in some parts of the

state. The most vulnerable children in our communities are missing out and this is creating an even bigger gap in the educational outcomes for children. Participation rates are falling across the state and we know from research that the 0-5 years are the most important time for a child's learning and development, and that children have better outcomes if they receive an early childhood education.

This week sees the start of a concerted campaign by preschool teachers to increase funding, reduce fees and make preschool education accessible, affordable and equitable for all children across NSW. We aim to make the NSW Government responsible for preschool education - this is the case in every other state in Australia where preschool fees are very low or non-existent.

We have asked the Premier Mr Barry O'Farrell, the Minister for Education and Communities Mr Adrian Piccoli and our local member Mr Thomas George to explain why NSW has reached this crisis point and how they aim to address the situation.

NSW is in a shameful situation compared to the rest of Australia, who seem to value the youngest members of their society more than the government of NSW does. **Kylie Kingston**

Family court farce

Like so many others, I applaud the announcement of a Royal Commission into child abuse. We have all heard horrific stories and know people who have suffered sexual abuse at the hands of religious organisations and state institutions. Sadly, children can also suffer abuse at the hands of their own parents.

What I find particularly appalling is the prevalence of false child abuse allegations being raised simply to gain advantage in Family Court proceedings. It is an absolute insult to anybody who has suffered real abuse, yet such deliberate perjury goes unpunished. In family law circles, such allegations are commonly referred to as the 'magic bullet' for resolving custody battles over children. Whoever makes an abuse allegation against the other parent first, typically wins custody of the children.

The courts operate focussing on the 'best interests of the child', so where there may be any kind of threat, then there is a presumption of guilt against the accused parent, and they are withdrawn from having contact with their own children. This of course gives full care of the child to the parent telling the lies and rewards them for doing so. For the alienated parent, the allegation may as well be a conviction.

This year, our parliament passed a bill which removed all penalties for making false allegations in the Family Court. It also broadened the definition of 'domestic violence' to be so vague that almost anything can now fit the criteria of 'domestic violence'. Be careful not to so much as raise your voice at your partner!

For those alienated parents who don't just give up or take their own life in despair, it can then take up to two years just to have the matter heard by the court, before they even have a chance to defend the allegation. Two years of separation from your children, just like that. The



Mayor Longland's faux pas

Mayor Barry Longland recently wrote a letter to the editor saying "the developer (of Kings Forest) sought a supplementary report from local ecologist and renowned koala expert, Dr Stephen Phillips... the Koala Plan of Management (KPoM) submitted with the Project Application and supported by the reports of both James Warren and Stephen Phillips did not recommend a ban on dogs in the development... the Stephen Phillips report also raised issues about dog size recommending a 10kg limit on dogs... three respected koala experts have not called for a ban on dogs."

Phillips has never written a report that contradicted his publicly stated views about dogs' impact on koalas. I clearly heard him say to the JRPP in May 2011 regarding the Cobaki Lakes development (by the same developer): "There is no such thing as a koalafriendly dog." That includes dogs under 10kg. Therefore why would he support a KPoM that did not have a dog ban in place? He didn't. The developer's ecologist writing the KPoM, Frank Carrick did.

The Mayor should correct his inaccurate statements to the media or lose credibility. His decision to support dogs at Kings Forest comes at a critical time right before Minister Tony Burke is to decide on a controlled action requiring a new KPoM, based on the latest decision by the Minister to declare koalas in NSW threatened and also the council's nomination to the NSW Scientific Committee to declare Tweed Coast koalas endangered. If there is no controlled action, then our coastal koalas will be finished. They desperately need every bit of protection they can get right now.

Since council staff recommends against dogs at Kings Forest, he cannot claim to follow their advice consistently.

The Mayor's only hope for redemption is if there is an urgent rescission motion and he votes against a dog ban. Otherwise he will have driven the last nail into the koalas' coffin and must live with the knowledge for the rest of his life that he was responsible for the localised extinction of one of the gentlest and most beautiful creatures on the planet.

What an embarrassment and shame!
